An IRP5 is used in respect of employees from whom tax has been deducted by their employer. On the other hand an IT3 (a) is used to report earnings of employees from whom tax has not been deducted. As with the IRP5 it must also be given to an employee who leaves the company during the tax year as well as to all employees who have not had tax deducted within the tax year.

The interim IRP5/IT3(a)s must not be issued to an employee, unless it is a final certificate (where the employee has left the service of the employer or the employer ceased to be an employer on or before 31 August

2018).
