For decedents dying on or after August 28, 2000, there is an estate administration procedure called a "Summary

Release from Administration". This procedure is available if the estate assets do not exceed \$45,000, and the applicant is the decedent's surviving spouse, who has paid the funeral bill or is obligated to do so, and who is also entitled to the entire allowance for support.
