Landlords Must Provide Written Notice Before Increase- If a landlord wants to increase a tenant's rent, the landlord must send the tenant a written notice. This notice can be hand delivered or mailed to the tenant.

Rent Increase In Quebec, at the time of the renewal of the lease, a landlord is free to ask a rent increase that he deems just and reasonable in his notice that he remits to his tenant. The tenant has the right to accept or to refuse that increase within one month following the receipt of the landlord's notice.

The landlord must give the tenant this notice at least 90 days before the date of the rent increase. A landlord may increase the rent if at least 12 months have passed since the last rent increase or since a new tenant moved into the rental unit.

Notice of Rent Increase - CPLEA - Landlord and Tenant

For example, if the landlord wants to increase the rent on November 1, the notice must be served on or before July 31 for the rent increase to be enforceable. For weekly periodic tenancies (where the tenancy goes week-to-week), the landlord must give the tenant at least 12 tenancy weeks notices of the rent increase.

Rent Increases - Province of British Columbia

Maximum Allowable Rent Increase. The landlord may only increase the rent 12 months after the date that the existing rent was established with the existing tenant(s) or 12 months after the date of the last legal rent increase, even if there is a new landlord or a new tenant by way of an assignment.

The tenant acknowledgment basically states what the current rents are, any side agreements that the tenant might have with the landlord (this could relate to rent rebates for cutting the lawn or shoveling the snow) and any other details of the tenancy.

LTB | 2018 Rent Increase Guideline

The 2018 rent increase guideline is 1.8% and applies to most private residential rental accommodation covered by the Residential Tenancies Act. The guideline is the most a landlord can increase the rent without applying to the LTB. **Annual Rent Increase Guideline | Landlord's Self Help Centre**

The rent increase guideline for 2019 is 1.8% unchanged from 2018. The 2019 guideline applies to rent increases that take effect between January 1, 2019 and December 31, 2019. Landlords may increase the rent once every 12 months by the guideline amount only for a sitting tenant without seeking approval from the Landlord and Tenant Board.

Where a landlord increases the amount of rent payable by a tenant, the increase shall be effective on the first day of a rental period, and the landlord is required to give the tenant written notice of: a not less than 8 weeks before the effective date of the increase where the residential premises is rented from week to week; and b not less than 6 months before the effective date of the

BC Residential Tenancies - Rent Increase Calculator
