Once the employee's short-term disability insurance benefits expire (generally after three to six months), the long-term disability insurance pays an employee a percentage of their salary, typically 50-70 percent.

Short-Term Disability Benefit Basics

If an employee must be out of work for longer than the short-term disability benefit coverage period, then either a long-term disability plan or permanent disability kicks in. This may happen at 10 to 53 weeks from the date of eligibility.

Understanding the Difference Between Short-term and Long ...

In Ontario, short-term disability is a period of disability for up to 15 weeks. This is based on the length of time the government provides EI support. For insurance companies, short-term disability extends for a period of six months. Short-term disability insurance and long-term disability insurance policies do not overlap.

Short-term disability vs long-term disability insurance

The elimination period for short-term disability insurance is usually under 14 days. Long-term policy elimination periods range from 30 days to two years, but the most common is 90 days. The longer the elimination period the longer you can go without accessing your policy benefits the cheaper the policy.
